

3 foot & 6 foot Drag Lite™ Models 10004485 & 10004486

Your shipping carton should include:


- (1) Rubber Drag Mat
- (1) Blade Bar
- (1) Parts Bag

Parts bag for 3' model should include:

- (8) "U" Bolts With Retaining Plates
- (16) ¼" KEPS Lock Nuts
- (1) 8' Chain

Parts bag for 6' model should include:

- (12) "U" Bolts With Retaining Plates
- (24) 1/4" KEPS Lock Nuts
- (1) 10' Chain







ASSEMBLY:

- Place the rubber mat on the ground with one of the long edges facing you.
 (Pic 1)
- Place the red blade bar (L shaped piece) on top of the mat with the holes for the "U" bolts against the mat. The blade bar should be centered from left to right, on the mat. This will show you where the "U" bolts should be installed. (Pic 2)
- Push each "U" bolt up through the mat from the underside, and then through the holes in the blade bar. NOTE: The "U" bolts straddle the wire that connects the rubber ribs. Secure each "U" bolt with one retaining plate and two lock nuts. (Pic 2) Note: If the U-bolts do not line up, or the mat is short, you may have to "stretch" the mat. Lay the mat on a flat surface, and pull and shake on end, while another person stands on the opposite end.
- Pass the ends of the two remaining "U" bolts that are on the ends of the chain, through the holes on each end of the blade bar. Secure the chain to each end of the blade bar with a retaining plate and two lock nuts. (Pic 3)



OPERATION:

Keep the blade bar on top of the mat to smooth a loose surface. Simply flip the mat over to use the teeth to loosen hard packed surfaces or to level high spots or fill in low areas.

For service under this warranty, buyer shall ship the defective part or parts of the equipment, transportation prepaid, to Newstripe, Inc. together with a written description of any claimed defect and proof of purchase date of the materials being returned. **Prior to retuning any part or machine, the CUSTOMER must obtain a Return Materials Authorization number. IT IS EXPRESSLY AGREED THAT THIS WARRANTY SHALL BE LIMITED TO THE ADJUSTMENT, REPAIR OR REPLACEMENT OF PARTS AND THE LABOR AND SERVICES REQUIRED THEREBY. IN NO EVENT, INCLUDING ANY CLAIM FOR NEGLIGENCE, SHALL NEWSTRIPE, INC. BE LIABLE FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES.
